### 6. Subscription:-

There will be no subscription from the members.

### 7. The Executive:-

### 8. Office Bearers:-

### 9. Elections and Meetings:-

- 1) The General meeting will be held once in a year, preferably before the beginning of the new session of the year.

A week's notice should be given for the general meetings. The meetings of the executive will be called at a week's notice. 24 hours notice is sufficient for an emergency meeting.

Any vacancy in executive arising out of resignation or transfer or death or any other cause shall be filled in way of nomination by the President of the P.T.A
