With reference to your application dated 30-03-2024 and subsequent correspondence with the school/inspection this regard, I convey the grant of Permanent recognition to Newton World School, Pind Malout for 1st Class to 8th Class.

The above sanction is subject to the fulfillment of the following conditions, namely:-

- The grant for recognition is not extendable and does not in any imply any obligation to recognize/affiliate beyond Class VIII.
- The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II)
- 3. The school shall admit in class I, to the extent of 25% of the strength of that class, children belonging to the weaker section and the disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion:

Provided, that in case of pre-primary cases also, this norm shall be followed.

- 4. For the children referred to in paragraph 3, the school shall be reimbursed as per subsection 2 of section 12 of the Act. To receive such reimbursement, the school shall provide a separate bank account.
- The school shall not collect any capitation fee and subject the child or his or her parents
 or guardians to any Screening Procedure.
- 6. The school shall not deny admission-

- Hymn

- a) To any child for lack of age proof; or
- If such admission is sought subsequent to the extended period, prescribed period prescribed for admission; or
- c) On the ground of religion, caste or race, place of birth or any or these reasons.

7. The school shall ensure that:--

- a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary Education in a school;
- b) no child shall be subjected to physical punishment or mental harassment;
- c) no child is required to pass any board examination till the completion or elementary education;
- d) every child completing elementary education shall be awarded a certificate as laid down under rule 21;
- e) inclusion of students with disabilities/special needs as per the provisions of the Act;
- f) the teachers are recruited with minimum qualifications, as laid under sub-section (1) of section 23/ provided that the existing teachers who, at the time of commencement of the Act, do not posses the minimum qualification, shall acquire such qualifications with in a period of 5 years from the date of commencement of the Act.
- g) The teachers perform their duties, specified under sub-section (1) of section 24 of the Act; and
- h) The teachers shall not engage himself or herself in any private teaching activities.
- The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- The school shall enroll students proportionate to the norms and standards available in the school as specified in section 19 of the Act.
- 10. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection, if made, are as given under:-
